In case of any doubt about a potential or actual conflict of interest, I agree to submit all relevant

materials.

- 3. I am not employed as an official as defined in clause 3.3 of the FSF Regulations Governing Intermediaries, and nor will I hold such position in the near future.
- 4. I have a good reputation, and I enclose a copy of my criminal record (an intermediary who comes from a country which does not issue criminal records based on similar criteria must submit other documentation of a similar nature).
- 5. Pursuant to clause 14.6 of the FSF Regulations Governing Intermediaries, I will not receive or make any payments to be made by one club to another in connection with a transfer, such as transfer fees, training compensation, solidarity contributions and any interest in a future transfer fee.
- 6. Pursuant to clause 14.8 of the FSF Regulations Governing Intermediaries, I will not receive any payment from the parties if the player in question is under the age of 18 when the player contract or the transfer agreement is signed.
- 7. I will not, whether directly or indirectly, engage or otherwise become involved in betting, gambling, lotteries, manipulation ("matchfixing"), similar unethical conduct, etc. in connection with football matches. I accept that I am forbidden from having an active or passive financial interest in companies, enterprises, organizations, etc. engaged in promoting, facilitating, arranging or conducting such events or transactions.
- 8. Pursuant to the FSF Regulations Governing Intermediaries in force from time to time, I consent to FSF obtaining the full details of all amounts of whatever nature paid by a club or a player to me for my intermediary activity.
- 9. Pursuant to the FSF Regulations Governing Intermediaries in force from time to time, I consent to FSF, UEFA and FIFA being given access to all contracts, agreements and documents in connection with my intermediary activity, if necessary for their investigations. Accordingly, I consent to those organizations also being given access to other relevant documentation from other parties advising on, facilitating or actively participating in the negotiations for which I am responsible.
- 10. Pursuant to the FSF Regulations Governing Intermediaries in force from time to time, I consent to FSF holding and processing any data for publication purposes.
